

2026 CHARRETT MOOT

PRELIMINARY INFORMATION

The Society of Construction Law Australia (**SoCLA**) Young Constructors Committee is excited to launch the Charrett Moot 2026 for young practitioners in the construction industry. The Charrett Moot 2026 will be conducted from April to May 2026.

Set out below is a brief overview of the moot, followed by a request for expressions of interest in participating in the moot.

OBJECTIVE

A key objective of the moot is to encourage young practitioners with limited public speaking experience to get involved in advocacy. The moot is designed to be a relaxed learning opportunity, while giving participants the chance to step out of their comfort zones in a supportive environment. The Grand Final will be held in front of leading industry figures, offering significant exposure to junior practitioners.

CRITERIA

Moot participants should be junior practitioners in the construction industry. Those at 4PQE or earlier, in all construction related industries are invited to participate. Students are also highly encouraged to participate (noting the 2024 reigning winners were a team of university students).

Please note that you do not need to be a member of the Society of Construction Law Australia to participate.

FORMAT

Where teams may be based in different states, territories or countries, video conferencing facilities will be utilised. There will be at least one judge present in each state for the duration of a moot.

STRUCTURE

Subject to demand, the structure of the competition will be as follows:

- Teams will consist of 3 or 4 participants (2 counsel and 1 or 2 solicitors). Individual participants may sign up and we will try our best to create a team for you, subject to availability.
 - The competition will be split into three rounds (Round 1, Round 2 (semi-finals) and a Grand Final).
 - Subject to demand, Round 1 will consist of 8 teams competing against each other.
 - The 4 winning teams will proceed to Round 2 to compete against each other.
 - The Grand Final will consist of the 2 winning teams from the previous round.
 - Team members within a team can swap positions at any time during the competition.

MOOTING PROBLEM

An original moot problem is currently being developed.

The same moot problem will be used for all rounds. The moot problem will test your knowledge of construction law and showcase your advocacy skills.

ADJUDICATION

We anticipate adjudication of the moots will be conducted by members of SoCLA, who are senior legal practitioners in the industry.

Grand Final: SoCLA Conference in Sydney (6 – 8 May 2026)
