

## 2021 CHARRETT MOOT

### PRELIMINARY INFORMATION

The Society of Construction Law Australia (**SoCLA**) Young Constructors Committee is excited to launch the 2021 Charrett Moot for young practitioners in the construction industry. The Charrett Moot 2021 will be conducted from August to October 2021.

Set out below is a brief overview of the moot, followed by a request for expressions of interest in participating in the moot.

### OBJECTIVE

A key objective of the moot is to encourage young practitioners with limited public speaking experience to get involved in advocacy. The moot is designed to be a relaxed learning opportunity, while giving participants the chance to step out of their comfort zones in a supportive environment.

---

### CRITERIA

Moot participants should be junior practitioners in the construction industry. Those at 4PQE or earlier, in all construction related industries are invited to participate. Students are also encouraged to participate.

**Please note that you must be a member of the Society of Construction Law Australia to participate.**

### FORMAT

The 2021 Charrett Moot is a national competition. Where teams are based in different states or territories, video conferencing facilities will be utilised. There will be at least one judge present in each state for the duration of a moot.

---

### STRUCTURE

Subject to demand, the structure of the competition will be as follows:

- Teams will consist of 3 or 4 participants (2 counsel and 1 or 2 solicitors). Individual participants may sign up and we will try our best to create a team for you, subject to availability.
  - The competition will be split into three rounds (Round 1, Round 2 (semi-finals) and a Grand Final).
  - Subject to demand, Round 1 will consist of 8 teams competing against each other.
  - The 4 winning teams will proceed to Round 2 to compete against each other.
  - The Grand Final will consist of the 2 winning teams from the previous round.
  - Team members within a team can swap positions at any time during the competition.

## **MOOTING PROBLEM**

The moot problem is currently being developed.

The same moot problem will be used for all rounds. The moot problem will test your knowledge of construction law as well as your advocacy skills.

## **ADJUDICATION**

We anticipate adjudication of the moots will be conducted by members of SoCLA, who are senior legal practitioners in the industry.
